

Why a Fund?

We believe a fund with capital of \$1 million will ensure Nuffield continues to be the pinnacle of leadership development in New Zealand. Income from the fund will enable five scholars every year and provide additional development & networking opportunities for Alumni. The fund will enable Nuffield to retain its independent voice as leadership development becomes a bigger industry focus.

The fund will also help the trustees to manage 'shocks' such as the loss of a major sponsor or a rural recession.

The Nuffield Capital Fund will be used exclusively for the Nuffield Scholarship programme and will be governed by the Nuffield Trustees.

Growing our capital fund from nearly \$750,000 to >\$1 million will ensure that Nuffield is in a strong position to spearhead rural leadership development for the next decade and beyond.

Fund Management

Through strategic investment the Nuffield Capital Fund has grown to almost \$750,000. The fund is managed by Craigs Investment Partners who provide advice on the allocation of funds across fixed income and cash, property, NZ equities, Australian Equities and global equities investments.

The fund has grown in value from investment returns at an annual rate of up to 12% p.a. over the past three years.

Our goal is to continue to grow the fund to use interest only for activities.

The Importance of Rural Leadership Development



Today's challenges to rural New Zealand appear daunting. Globalisation is offering better but more volatile prices. Our major co-operatives are under pressure in terms of performance and access to capital. We are faced with questions that suggest that production and the environment are mutually exclusive. The economics of farming combined with modern lifestyles mean that succession

of ownership is problematic for many farming families. And the divide in common interest and understanding between rural and urban communities has never been greater.

Yet history says that our rural leaders have managed difficult challenges in the past. Examples include the ascension of the United Kingdom into the EU with changes to market entry (1970's), high interest rates and deregulation (mid to late 1980's), the introduction of Resource Management legislation (1991) and the never-ending need to improve our products and produce them at a lower cost.

Farmer leaders have played crucial roles through these challenging times and 'Nuffielders' have played their part.

The unique program develops self, fosters networks, develops expertise on a chosen topic and helps place New Zealand within a global context.
